Auditing for Environmental Compliance™ is an intensive, two-day program that prepares EHS professionals to lead internal environmental compliance audits, serve effectively on audit teams, and build audit programs that deliver measurable organizational value.

Unlike regulation-specific training, this course does not focus solely on theoretical knowledge and checklist verification, but rather on the principles, structure, and realities of multimedia environmental compliance auditing across federal and state programs.

This course is led by a Certified Professional Environmental Auditor (CPEA) with more than 25 years of national compliance and enforcement experience, including support for USEPA enforcement programs and consent decree auditing. Participants gain insight into how regulators evaluate audit findings, how enforcement risk develops, and how to design audit programs that strengthen compliance posture while minimizing unintended exposure.

Business Case for Attendance

The cost of undiscovered violations far exceeds the cost of finding them. EPA's civil enforcement program resolved over 1,851 cases in fiscal year 2024, assessing more than \$1.7 billion in penalties. Facilities that lack structured internal audit programs are more likely to accumulate undetected violations that compound over time, leading to larger penalties, corrective action requirements, and supplemental environmental project obligations when regulators discover them. A national parts-washing services company paid \$1,162,500 for RCRA hazardous waste management violations across multiple states—violations that a well-designed internal audit program could have identified and corrected before enforcement. EPA's Audit Policy provides incentives for organizations that voluntarily discover, promptly disclose, and expeditiously correct violations, including elimination or significant reduction of gravity-based penalties.

This course reduces reliance on outside consultants. After completing the Auditing for Environmental Compliance™ course, your employee returns prepared to design and execute structured environmental compliance audit programs, evaluate internal controls, develop defensible findings, and communicate audit results to management. Each of these tasks would otherwise require consultant support at rates that typically exceed the cost of this course in a matter of days.

The investment is immediate and practical. Course content is applied, not academic. Participants return with actionable knowledge, reference materials, and direct access to the course presenter for follow-up questions as compliance challenges arise.
