NEPA Navigator™ is an intensive, three-day course that prepares professionals to effectively support, manage, and lead the National Environmental Policy Act (NEPA) process.

Instruction is informed by firsthand experience preparing NEPA documents for the U.S. Army, Bureau of Land Management, Bureau of Reclamation, Bureau of Indian Affairs, and the National Park Service, as well as managing Environmental Impact Reports (EIRs) under the California Environmental Quality Act (CEQA).

Since 2010, this course has equipped federal employees, consultants, project proponents, and private-sector managers with the knowledge and practical tools required to develop defensible NEPA documentation and guide projects through federal review.

Business Case for Attendance

NEPA process errors are costly in both time and money. Inadequate or poorly prepared NEPA documentation frequently results in project delays measured in months or years, litigation costs that can reach hundreds of thousands of dollars, and court-ordered injunctions that halt projects entirely. Federal courts have remanded or vacated agency decisions in numerous cases where Environmental Assessments or Environmental Impact Statements were found to contain inadequate alternatives analysis, insufficient cumulative impact evaluation, or failure to take a “hard look” at environmental consequences. For major infrastructure, energy, and development projects, delays caused by NEPA challenges routinely cost organizations millions in lost revenue, additional financing costs, and resource reallocation. Personnel who understand the NEPA process can help avoid the documentation weaknesses that lead to successful legal challenges.

This course reduces reliance on outside consultants. After completing the NEPA Navigator™ course, your employee returns prepared to support or lead the NEPA process, develop defensible Purpose and Need statements, evaluate alternatives, assess cumulative impacts, coordinate with stakeholders, and manage NEPA documentation timelines. Each of these tasks would otherwise require consultant support at rates that typically exceed the cost of this course in a matter of days.

The investment is immediate and practical. Course content is applied, not academic. Participants return with actionable knowledge, reference materials, and direct access to the course presenter for follow-up questions as NEPA challenges arise.

- The intent, structure, and implementing regulations of the National Environmental Policy Act of 1969
- The three levels of NEPA documentation: Categorical Exclusions (CXs), Environmental Assessments (EAs), and Environmental Impact Statements (EISs)
- Determining the appropriate NEPA pathway for proposed actions, including borderline and complex situations
- Developing a clear and defensible Purpose & Need statement
- Defining the Proposed Action and evaluating reasonable alternatives
- Scoping processes and stakeholder engagement
- Characterizing the affected environment and conducting environmental consequences analyses
- Evaluating cumulative impacts and mitigation measures
- Preparing Records of Decision (RODs) and Findings of No Significant Impact (FONSI)s
- Interrelationships between NEPA and other federal laws, including the Endangered Species Act, Clean Water Act, and National Historic Preservation Act
- Agency-specific implementation considerations and documentation expectations
- Practical tips for document review, coordination with contractors, and managing schedules and timelines
