Business Case for Attendance

Anyone who classifies, packages, marks, labels, prepares shipping papers for, or offers hazardous materials or dangerous goods for transportation is a “hazmat employee” under federal law—and must be trained. *This includes anyone who signs hazardous waste manifests.* Non-compliance exposes your organization to civil penalties of up to \$60,000 per violation and potential criminal liability.

The Dangerous Goods Compliance Manager satisfies the training requirements of 49 CFR Subpart H for ground shipments, the IATA Dangerous Goods Regulations for air, and the IMO International Maritime Dangerous Goods (IMDG) Code for ocean. The course covers initial and recurrent training requirements and includes an optional lithium battery transportation module.

The presenter walks students through how to read, interpret, and apply the regulations to real-world shipping scenarios. Students work through case studies highlighting the methods, exceptions, and documentation requirements specific to each mode. You will leave with actionable knowledge and the tools to prepare compliant shipments and minimize regulatory risk.

Who Should Attend

This course is designed for hazmat employees as defined in 49 CFR 171.8, personnel required to be trained under IATA 1.5 and IMDG 1.3, and hazardous waste generators who sign waste manifests. If you classify, package, document, or offer hazardous materials or dangerous goods for any mode of transport—or sign a hazardous waste manifest—this course is for you.

Ship only by ground? Hazardous waste generators and others who ship exclusively by highway should consider our two-day ***Dangerous Goods Ground Shipper*** course, which is simply the first two days of this course, designed to satisfy 49 CFR training requirements without the full four-day commitment.

Course Format
